There was a major revolution in agricultural production in the country in the 20<sup>th</sup> century. However, in the 21st century, recognizing the need to add value to agricultural produce, grow the agro-processing industry and create a marketing chain for agricultural produce, a separate training department has been established by the Corporation in January 2019.

Through this department, for entities viz cooperative societies, farmer producer companies, Women self-help groups, more than 250 training programmes on various topics including high-tech agriculture have been organized, wherein, around and 15,000 farmers have been trained in the last five years.
